# WHAT CAN PPS\*CLEARING DO FOR YOU?

- PPS\*Clearing was launched in 2012 to secure and facilitate settlements between DOs exchanging postal payment services electronically within the same network
- PPS\*Clearing is a receivable-driven clearing system open to all designated operators of UPU member countries that have signed to the PPS Agreement and that are members of the PPS User group



#### LINK TO A SETTLEMENT PROVIDER

#### AUTOMATED CLEARING AND SETTLEMENT

Could you benefit from a system that automates clearing and settlement between you and your partners?



#### CURRENCY CONVERSION

# BILATERAL SETTLEMENT VERSUS CENTRALIZED CLEARING

#### WITHOUT PPS\*CLEARING

DOs settle their accounts bilaterally and manually at intervals defined in bilateral agreements



 Difficult process when many countries and currences are involved

#### WITH PPS\*CLEARING

A centralized clearing and settlement system prevents a multiplication of settlement agreements (and periodic payments)



- Ensures payment discipline through a pre-defined clearing calendar
- Reduces exposure to FX risk through the use of a limited number of currencies and FX adjustment mechanisms
- Reduces exposure to default risk through strict financial rules

# HOW DOES PPS\*CLEARING WORK?

#### ON A WEEKLY BASIS:

- PPS\*Clearing generates bilateral invoices, consolidates them and calculates net positions for each designated operator
- The clearing house receives payments from net debtors and pays net creditors through the settlement provider once per week

# THE SYSTEM IS AUTOMATED

#### AND PROVIDES DESIGNATED OPERATORS WITH:

- Detailed bilateral invoice statements on financial traffic
- Net statements
- Daily exchange rates (supplied by a common, reliable exchange rates provider)
- Confirmation of settlement (from settlement provider)
- Confidentiality and a secure environment

#### COMPATIBILITY:

- The system supports EDI messages that are compliant with UPU standards (MS38-5 and above)
- The system can be used in conjunction with the PTC's IFS software suite. For more information on IFS, please see our dedicated documentation

# CLEARING CALENDAR

- The calendar is published every year by the clearing house and shows the clearing cycle for each month
- There are four to five clearing cycles in each month

# WHAT ARE THE BENEFITS OF JOINING PPS\*CLEARING?

#### **OPERATIONAL**

PPS\*Clearing helps designated operators:

- Optimize their administrative and banking costs
- Facilitate the process of data reconcilitation and cash-flow management
- Reduce the risk of errors caused by a manual process
- Reduce the number of payments to one payment per country (by generating a single net position for each member)

#### GOVERNANCE

- PPS\*Clearing is managed by the UPU International Bureau
- It is a service from the PPS User Group
- Clear rules and procedures govern the User Group and PPS\*Clearing operations to ensure the security of financial settlements between members

# HOW TO USE PPS\*CLEARING

All members exchanging postal payment services within the UPU network can join the PPS User Group at any time of the year and at an affordable cost
