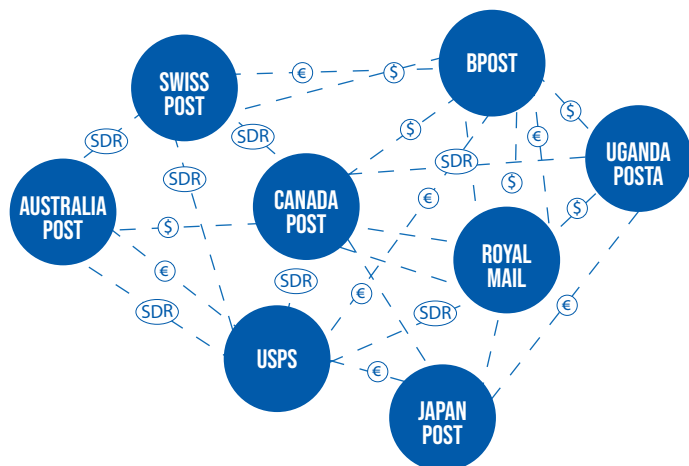
The payment processing time has been reduced from an average of 6 months to a maximum of 55 days, as all payments are processed by the 25th day of the month following the one in which the transaction took place.

The system has enabled the Brazilian Post to produce an administrable cash flow, which had never before been possible in its international accounts. Brazilian legislation, and probably that of other countries, requires 25% of funds sent abroad to be withheld as income tax.

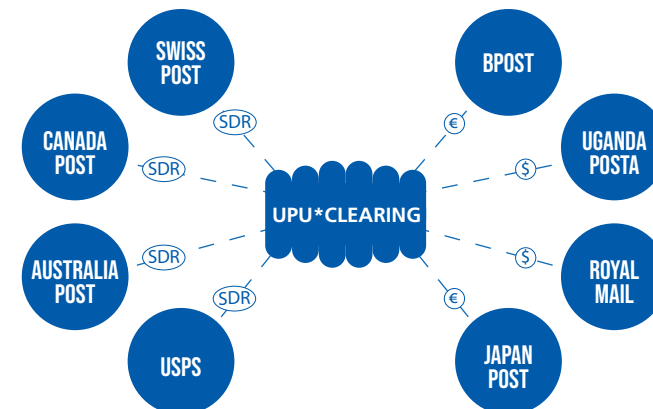
How does it work?

Before UPU*Clearing



The **UPU*Clearing** system consolidates transactions and calculates settlement. Payments are centralized, with just one monthly payment for each debtor in EUR and/or USD.

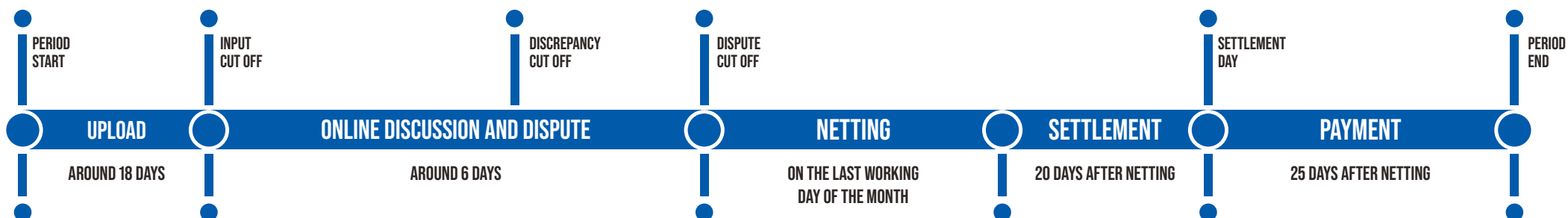
